MINUTES

The City of Baker School Board met in regular session in the Board Room of the City of Baker School Board Office beginning at 6:00 p.m. on January 9, 2018.

Mrs. Johnson thanked her fellow Board Members for their cooperation and assistance during her term as President.

Superintendent Brister presented Mrs. Johnson with a plaque that had a picture of her, the dates of her term, and the District's accomplishments under her leadership.

At this time, Dr. Carpenter took charge of the meeting.

On motion of Mrs. Davis seconded by Mrs. Johnson, the Board voted to accept the Financial Report for the Period Ending November, 2017 as presented by Ms. Elantria Coleman, Finance Specialist. Voting yes: Carpenter, Davis, Boxie, Dees and Johnson. Voting no: None.

On motion of Mrs. Davis seconded by Mrs. Boxie, the Board voted to approve a contract with Mass Insight Education (MIE) to assist in the implementation of School Redesign for Bakerfield Elementary School, Baker Middle School and Baker High School. On motion of Mrs. Johnson seconded by Mrs. Boxie, the Board voted to approve a memorandum of understanding between Upward Bound Math & Science Program-Project Discovery, Southern University and Baker High School. Voting yes: Davis, Boxie, Dees and Johnson. Voting no: None. * Dr. Carpenter recused himself from voting because of his relationship with the program.

Superintendent Brister made the following announcements/remarks:
