

CITY OF BAKER SCHOOL BOARD MEETING June 16, 2015

MINUTES

The City of Baker School Board met in the Board Room of the City of Baker School Board Office beginning at 6:00 p.m. on June 16, 2015. Mrs. Elaine G. Davis, Board President, called the public meeting to order.

On motion of Mrs. Boxie seconded by Mrs. Johnson, the Baord voted to approve the City of Baker School Board 2014-2015 Amended Operating Budget as presented by Mrs. Sidney Stewart, Business Manager. Voting yes: Davis, Boxie, Alexander, Carpenter and Johnson. Voting no: None.

On motion of Dr. Carpenter seconded by Mrs. Alexander, the Board voted to approve a Letter of Engagement with Postlethwaite & Netterville to conduct a financial audit of the City of Baker School System as of and for the year ended June 30, 2015. On motion of Dr. Carpenter seconded by Mrs. Johnson, the Board voted to approve designating *The Advocate* as the official Journal of Record for the City of Baker School Board for the period July 1, 2015 to June 30, 2016. Voting yes: Davis, Boxie, Alexander, Carpenter and Johnson. Voting no: None.

Superintendent Brister requested the Board defer Agenda Item #8: "Consideration and Approval to Renew the Updating Service with Forethought Consulting, Inc. for July, 2015 through June, 2016" until the next Board meeting. On motion of Mrs. Alexander seconded by Mrs. Boxie, the Board voted to defer Agenda Item #8 until the next Board meeting. Voting yes: Davis, Boxie, Alexander, Carpenter and Johnson. Voting no: None.

On motion of Mrs. Boxie seconded by Mrs. Johnson, the Board voted to approve acceptance of the appropriate and/or lowest proposal for lawn maintenance effective July 1, 2015 through October 30, 2015. Voting yes: Davis, Boxie, Alexander, Carpenter and Johnson. Voting no: None.

Mrs. Davis announced the Board would hold a retreat on July 10 and July 11, 2015. As there was a conflict, the Board agreed to reschedule the retreat for Wednesday, July 15, 2015 (12:00 p.m. – 5:00 p.m.), and Thursday, July 16, 2015 (9:00 a.m. – 1:00 p.m.).

Superintendent Brister requested the Board hold a work session prior to June 30, 2015, to receive and discuss information from Mr. Kerry Drake and Ms. Jeanne Wallace, with Wright and Percy Insurance, on the health insurance benefits renewal for the City of Baker School System for 2015-2016. The Board agreed to hold a work session on Tuesday, June 23, 2015, beginning at 6:00 p.m. to discuss this item.

Mrs. Davis thanked those in attendance for coming and announced the next regular meeting of the City of Baker School Board would be held on Tuesday, July 7, 2015, beginning at 6:00 p.m.
