

## CITY OF BAKER SCHOOL BOARD MEETING July 1, 2014

## MINUTES

The City of Baker School Board met at Park Ridge Academic Magnet School beginning at 6:00 p.m. on July 1, 2014. Dr. Dana Carpenter, Board President, called the meeting to order.

A moment of silent meditation was led by Mrs. Boxie, followed by the Pledge of Allegiance led by Ms. Watson. Dr. Carpenter welcomed all visitors to the meeting.

At the request of Dr. Carpenter and by general consent of the Board, the agenda was amended to add the following as Agenda Item #19: "Approval to Designate Monday, July 7, 2014, as a Holiday for City of Baker School System 12-month Employees."

On motion of Mrs. Davis seconded by Ms. Watson, the Board voted to approve the agenda as amended. Voting yes: Carpenter, Davis, Alexander, Boxie and Watson. Voting no: None.

On motion of Mrs. Davis seconded by Mrs. Boxie, the Board voted to approve the minutes from the meeting of June 10, 2014. Voting yes: Carpenter, Davis, Alexander, Boxie and Watson. Voting no: None.

On motion of Mrs. Davis seconded by Mrs. Boxie, the Board voted to approve the Superintendent's personnel actions. Voting yes: Carpenter, Davis, Boxie and Watson. Voting no: None. Abstaining: Alexander.

On motion of Mrs. Davis seconded by Mrs. Boxie, the Board voted to approve the Superintendent entering into a preventive maintenance contract with Star Services, Inc. for HVAC services for the School Board Office. Voting yes: Carpenter, Davis, Alexander, Boxie and Watson. Voting no: None.

On motion of Mrs. Davis seconded by Mrs. Boxie, the Board voted to approve acceptance of the lowest bid and enter into a contract with Patriot Industries for renovations at the City of Baker School Board Office, 14750 Plank Road, Baker, Louisiana in the amount of \$121,900. On motion of Mrs. Davis seconded by Mrs. Boxie, the Board voted to approve the revised admission criteria for Park Ridge Academic Magnet School for 2014-2015. Voting yes: Carpenter, Davis, Alexander, Boxie and Watson. Voting no: None.

Voting no: None. Absent: Alexander.

On motion of Mrs. Davis seconded by Mrs. Boxie, the Board voted to authorize the Superintendent to charge \$1.00 per page for copies of documents/information requested by the public exceeding four (4) pages. Voting yes: Carpenter, Davis and Boxie. Voting no: Watson. Absent: Alexander.

On motion of Mrs. Davis seconded by Mrs. Boxie, the Board voted to go with the lowest bidder for Workers' Compensation Insurance for 2014-2015 -- Berkshire Hathaway Homestate Insurance Company. Voting yes: Carpenter, Davis, Boxie and Watson. Voting no: None. Absent: Alexander.

On motion of Mrs. Davis seconded by Mrs. Boxie, the Board voted to approve adding Biology I, Algebra I and Journeys to Careers for high school credit at Park Ridge Academic Magnet School. Voting yes: Carpenter, Davis, Boxie and Watson. Voting no: None. Absent: Alexander.

On motion of Mrs. Boxie seconded by Mrs. Davis, the Board voted to approve a \$1,500 supplement for full-time, certified City of Baker School System employees and a \$1,000 supplement for full-time support employees with one-half to be paid in November, 2014, and one-half paid in April, 2015.
