- 1. Newsletters from each school went home to parents today. I'm told this is the first time that all schools prepared newsletters and sent them out on the same day.
- 2. Baker Heights and Bakerfield Elementary Schools and Baker Middle School completed initial placement testing last week in SuccessMaker math and reading.
- 3. Acuity testing has begun.
- 4. DRA reading assessment started this week to determine our literacy intervention.
- 5. DIBELS testing was completed in short order. Staff completed this task two months earlier than last year.
- 6. The Baker High School Football Team will be undertaking community projects.
- 7. Baker Middle School's Band received word today that it is recipient of an "Action for the Arts" Grant from The House of Blues Music Forward Foundation in the amount of \$3,000. Mr. Tory Williams, Baker Middle School's Band Director, will use the funds to repair instruments and to purchase a new tuba for the band.
- 8. Thank you to everyone who participated in the Town Hall Meeting on August 25, 2015, and thank you to Baker High School for hosting the event in the school's auditorium.

Mrs. Davis thanked those in attendance for coming and announced the next meeting of the City of Baker School Board would be held on Tuesday, October 6, 2015, at 6:00 p.m. in the Board Room of the School Board Office.
