

City of Baker School Board April 13, 2021

MINUTES

The City of Baker School Board held a public meeting via Zoom beginning at 6:00 p.m. on Tuesday, April 13, 2021.

President Parker explained that while conducting Board Meetings via Zoom, the public can attend the meeting and also ask questions/make comments by using the email address: comments@bakerschools.org. Since the meeting is virtual, all votes will be taken by roll call.

President Parker called the meeting to order and took roll call:

A moment of silent meditation was led by Mrs. Davis, followed by the Pledge of Allegiance led by Mrs. Boxie.

President Parker welcomed all persons participating in the meeting.

On motion of Mrs. Burges seconded by Ms. Booker, the Board voted to adopt the *Certification of Inability to Achieve In-person Quorum & Notice to Meet through Electronic Means*. Voting yes: Parker, Boxie, Booker, Burges and Davis. Voting no: None.

President Parker asked for a motion to consider all items on the agenda (Act 42 of 2020, 2nd Extraordinary Session).

Mrs. Burges made a motion to delete Item #16 from the agenda:

"Consideration and Approval to Terminate Contract with Manning Architects"

Mrs. Davis seconded Mrs. Burges' motion. Discussion ensued and a vote was taken. Voting yes: Burges and Davis. Voting no: Parker, Boxie and Booker.

On motion of Mrs. Boxie seconded by Mrs. Davis, the Board voted to approve the Annual Audit Report Year Ended June 30, 2020, prepared by Kolder, Slaven & Company, LLC as presented by Mr. Mathew E. Margaglio, CPA. Voting yes: Parker, Boxie, Booker, Burges and Davis. Voting no: None.

On motion of Mrs. Burges seconded by Mrs. Boxie, the Board voted to renew the agreement with Kolder, Slaven & Company, LLC (Certified Public Accountants) to provide services year ended June 30, 2021 and 2022. Voting yes: Parker, Boxie, Booker, Burges and Davis. Voting no: None.

On motion of Mrs. Burges seconded by Mrs. Davis, the Board voted to accept the monthly financial report including budget to actual comparisons for the period ending February 28, 2021, as presented by Mrs. Sidney Stewart, Business Manager. Voting yes: Parker, Boxie, Booker, Burges and Davis. Voting no: None.

A motion was made by Mrs. Burges to remove Agenda Item #16 from the agenda: "Consideration and Approval to Terminate Contract with Manning Architects". The motion was seconded by Mrs. Davis. Mrs. Burges then amended her motion from "delete" to "table" Agenda Item #16. The amended motion was seconded by Mrs. Davis. Voting yes: Parker, Boxie, Booker, Burges and Davis. Voting no: None.

On motion of Mrs. Boxie seconded by Ms. Booker, the Board voted to authorize the issuance of a Request for Proposals (RFP) for the rehabilitation of Baker High School, said proposal will include but not be limited to architectural, engineering, financing and/or construction services. Voting yes: Parker, Boxie, Booker, Burges and Davis. Voting no: None.

On motion of Mrs. Davis seconded by Mrs. Boxie, the Board voted to approve the renewal of flood insurance with Wright National Flood Insurance Company for the period April 16, 2001 to April 16, 2022. Voting yes: Parker, Boxie, Booker, Burges and Davis. Voting no: None.

On motion of Mrs. Boxie seconded by Mrs. Booker, the Board voted to award the lawn maintenance services contract to MCC Landscape and Lawn, LLC for the period July 1, 2021 to June 30, 2022. Voting yes: Parker, Boxie, Booker and Burges. Voting no: Davis.

Interim Superintendent Perry had no remarks.

President Parker thanked those participating in the meeting and announced the next meeting of the City of Baker School Board would be held on Tuesday, May 4, 2021, beginning at 6:00 p.m. On Saturday, April 24th, the Board will interview finalists for the position of Superintendent of the City of Baker School System beginning at 9:00 a.m.
