

City of Baker School Board March 16, 2021

MINUTES

The City of Baker School Board held a public meeting beginning at 6:30 p.m. on Tuesday, March 16, 2021.

President Parker called the meeting to order and took roll call:

A moment of silent meditation was led by Mrs. Boxie, followed by the Pledge of Allegiance led by Mrs. Burges.

President Parker welcomed all visitors to the meeting.

On motion of Mrs. Boxie seconded by Ms. Booker, the Board voted to approve the agenda as presented. Voting yes: Parker, Boxie, Booker, Burges and Davis. Voting no: None.

Mr. Mike Faulk, Superintendent Search Consultant, announced the names of the candidates for the position of Superintendent of the City of Baker School System:

The three (3) candidates with the most votes and who will be interviewed are:

Mr. Faulk proposed the following interview process:

- Two hours will be allotted for each interview.
- There will a random drawing by each applicant to determine the order of the interviews.
- Board Members will ask the interview questions.
- Mr. Faulk will prepare a bank of questions. These will be shared with the Board on April 9, 2021 for a decision on which questions will be asked. Interview questions will be assigned to each Board Member.
- The interviews will be held on Saturday, April 24, 2021:
 - Interviews will begin at 9:00 a.m.
 - First interview from 9:00 a.m. to 11:00 a.m.
 - Lunch from 11:00 a.m. to 12:00 p.m.
 - Second interview from 12:00 p.m. to 2:00 p.m.
 - Third interview from 2:00 p.m. to 4:00 p.m.

On motion of Ms. Booker seconded by Mrs. Burges, the Board voted to interview Dr. De'Ette Perry, Ms. Tamara Johnson and Dr. Calvin Nicholas. The Board will ask the interview questions and the interviews will be conducted on Saturday, April 24, 2021. Voting yes: Parker, Boxie, Booker, Burges and Davis. Voting no: None.

On motion of Mrs. Davis seconded by Ms. Booker, the Board voted to bring the name of the applicant to be selected as Superintendent of the City of Baker School System for a vote at the meeting on May 4, 2021. Voting yes: Parker, Boxie, Booker, Burges and Davis. Voting no: None.

On motion of Mrs. Burges seconded by Ms. Booker, the Board voted to have the Board President, Vice President and Board Attorney negotiate a contract with the successful candidate and bring the contract to the Board Meeting on June 1, 2021 for approval. The new Superintendent will begin employment on July 1, 2021. Voting yes: Parker, Boxie, Booker, Burges and Davis. Voting no: None.

Mr. Faulk will draft and send letters to the successful applicants and contact the applicants who will not be interviewed.

President Parker thanked those in attendance and announced the next meeting of the City of Baker School Board would be held on Tuesday, April 13, 2021, beginning at 6:00 p.m.
