

City of Baker School Board May 4, 2021

MINUTES

The City of Baker School Board held a public meeting via Zoom beginning at 6:00 p.m. on Tuesday, May 4, 2021.

President Parker explained that while conducting Board Meetings via Zoom, the public can attend the meeting and also ask questions/make comments by using the email address: comments@bakerschools.org. Since the meeting is virtual, all votes will be taken by roll call.

President Parker called the meeting to order and took roll call:

A moment of silent meditation was led by Mrs. Burges, followed by the Pledge of Allegiance led by Ms. Booker.

President Parker welcomed all persons participating in the meeting.

On motion of Mrs. Burges seconded by Mrs. Boxie, the Board voted to approve the agenda as presented. Voting yes: Parker, Boxie, Booker, Burges and Davis. Voting no: None.

On motion of Mrs. Davis seconded by Mrs. Burges, the Board voted to approve the minutes from the meeting of April 13, 2021. Voting yes: Parker, Boxie, Booker, Burges and Davis. Voting no: None.

There was no old business.

On motion of Mrs. Boxie seconded by Mrs. Burges, the Board voted to adopt the *Certification of Inability to Achieve In-person Quorum & Notice to Meet through Electronic Means*. Voting yes: Parker, Boxie, Booker, Burges and Davis. Voting no: None.

On motion of Mrs. Burges seconded by Ms. Booker, the Board voted to consider all items on the agenda (Act 42 of 2020, 2nd Extraordinary Session). Voting yes: Parker, Boxie, Booker, Burges and Davis. Voting no: None.

De'Ette Perry, Ed.D., Interim Superintendent presented the Quest to Excellence Award to:

Ms. Johnson is a certified educator, mentor, certified leadership consultant and inspirational speaker. Within the community she has worked primarily with young girls and women providing wisdom, encouragement and guidance. At Baker Middle School, Ms. Johnson is an outstanding Jobs for America's Graduates (JAG) Specialist. Since her tenure at Baker Middle School, her students have been elected for leadership roles as JAG-LA state officers. This year, Ms. Johnson was selected by JAG National to work on the Middle School Task Force to revise the middle school curriculum. Also, she was selected as a National JAG Trainer.

Mr. John Arrasmith, Student of the Year Coordinator, presented the City of Baker School System Students of the Year:

Mr. David Grisby, Human Resources Supervisor, presented the Interim Superintendent's personnel appointments. On motion of Mrs. Davis seconded by Mrs. Boxie, the Board voted to accept the certified personnel appointments and to approve the non-certified personnel appointments. Voting yes: Parker, Boxie, Booker, Burges and Davis. Voting no: None.

On motion of Mrs. Boxie seconded by Ms. Booker, the Board voted to approve the job description for 12-Month Athletic Director. Voting yes: Parker, Boxie and Booker. Voting no: Davis. Abstaining: Burges.

Following discussion, Mrs. Boxie made a motion to rescind her previous motion. Ms. Booker seconded her motion. Voting yes: Parker, Boxie, Booker, Burges and Davis. Voting no: None.

Mrs. Boxie made a motion to approve the job description for 12-Month Athletic Director pending review by the Board Attorney. Ms. Booker seconded the motion. Voting yes: Parker, Boxie and Booker. Voting no: Davis. Abstaining: Burges. The motion passed.

On motion of Mrs. Burges seconded by Mrs. Boxie, the Board voted to leave the open meeting and go into executive session to discuss the selection of the Superintendent for the City of Baker School System. Voting yes: Parker, Boxie, Booker, Burges and Davis. Voting no: None.

On motion of Mrs. Burges seconded by Mrs. Boxie, the Board voted to leave executive session and return to the open meeting. Voting yes: Parker, Boxie, Booker, Burges and Davis. Voting no: None.

Her motion was seconded by Ms. Booker.

A vote was taken. Voting yes: Parker, Boxie, Booker and Burges. Abstaining: Davis.

The Board congratulated Dr. Perry on being elected Superintendent of the City of Baker School System. Dr. Perry thanked the Board for the opportunity to continue to serve the students and families in the City of Baker School System.
