MINUTES

- 2. <u>Update from CSRS on High School Construction</u> Mr. Brian Budd, with the CSRS Program Management Team provided the following

information:

- Construction is progressing at a good pace
- We passed inspection on rough end for plumbing, electrical, and HVAC
- There is an issue with the transformer. It was supposed to be here in March, but has now been pushed back to May. We've made contact with the Entergy folks and they're trying to get us a smaller transformer that we can utilize as a temporary transformer until the permanent one comes in.
