

City of Baker School Board Public Hearing/Meeting July 25, 2018

MINUTES

The City of Baker School Board held a public hearing in the Board Room of the City of Baker School Board Office beginning at 6:00 p.m. on July 25, 2018.

Dr. Dana Carpenter, Board President, opened the public hearing and informed the audience the hearing was to consider approval of the City of Baker School Board proposed operating budget for 2018-2019.

Mrs. Sidney Stewart, Business Manager, presented an overview of the 2018-2019 operating budget. She then asked for questions and/or comments.

As there were no questions or comments from the audience, Dr. Carpenter announced the public hearing was now closed and the Board would go into a public meeting.

On motion of Mrs. Davis seconded by Mrs. Johnson, the Board voted to approve the operating budget for 2018-2019, with the transfer of \$94,115.01 from general funds as a loan to cover the deficit in School Food Service. Voting yes: Carpenter, Davis, Boxie, Dees and Johnson. Voting no: None.

On motion of Mr. Dees seconded by Mrs. Johnson, the Board voted to approve property insurance, liability insurance and workers compensation packages with Starr Surplus Lines. Voting yes: Carpenter, Davis, Boxie, Dees and Johnson. Voting no: None.

On motion of Mrs. Davis seconded by Mrs. Boxie, the Board voted approval to elect uninsured/underinsured motorist bodily coverage with a \$250,000 limit to the automobile policy, and authorized Dr. Herman Brister, Superintendent, to sign on behalf of the City of Baker School Board to elect uninsured/underinsured motorist bodily coverage to the automobile policy, contingent upon the Board's legal counsel researching the item to determine if this is necessary. On motion of Mrs. Davis seconded by Mr. Dees, the Board voted to continue with BlueCross BlueShield for the health care and supplemental insurance packages for the 2018-2019 enrollment plan year. Voting yes: Carpenter, Davis, Boxie, Dees and Johnson. Voting no: None.

On motion of Mrs. Davis seconded by Mrs. Johnson, the Board voted to approve a letter of engagement with Fontenot Benefits and Actuarial Consulting to provide actuarial calculations as required by Governmental Accounting Standards Board (GASB) 75. On motion of Mrs. Boxie seconded by Mrs. Johnson, the Board voted to approve a letter of engagement with Kolder, Slaven & Company to perform the United States Department of Agriculture (USDA) preliminary feasibility report certification. On motion of Mrs. Boxie seconded by Mrs. Johnson, the Board voted to approve the 2018-2019 janitorial paper and chemical supply bid awarded to Economical Paper & Janitorial Supply. Voting yes: Carpenter, Davis, Boxie, Dees and Johnson. Voting no: None.

On motion of Mrs. Davis seconded by Mrs. Boxie, the Board voted to approve the *Student Rights & Responsibilities Handbook and Discipline Policy* revisions for 2018-2019. Voting yes: Carpenter, Davis, Boxie, Dees and Johnson. Voting no: None.

On motion of Mrs. Davis seconded by Mr. Dees, the Board voted to approve the revised/new policies for inclusion in the City of Baker School Board Policy Manual as reviewed during the June 18, 2018 City of Baker School Board Work Session, and also the changes indicated by Board Attorney, Winston DeCuir, Sr. Voting yes: Carpenter, Davis, Boxie, Dees and Johnson. Voting no: None.

On motion of Mrs. Davis seconded by Mrs. Boxie, the Board voted to exit regular session and go into executive session to consider the settlement of Carlisa Bell v.
