

## City of Baker School Board April 9, 2019

## **MINUTES**

The City of Baker School Board held a meeting in the Board Room of the City of Baker School Board Office beginning at 6:00 p.m. on April 9, 2019.

Mrs. Shona P. Boxie, President, called the meeting to order.

On motion of Mrs. Burges seconded by Ms. Booker, the Board voted to increase the \$10.50 hourly rate of pay for after-school tutoring, extended day programs and field trips to \$15.25 per hour for bus operators, effective April 10, 2019. Superintendent Brister made the following announcements/remarks:

- 1. Our students are testing well, with 99.5% attendance.
- 2. The District is participating with Southern University in a grant from the National Science Foundation, to increase participation in computer science. We are also participating in a STEM grant with LSU.
- 3. Four students from Park Ridge Academic Magnet School were inducted into the Youth Legislature on March 26, 2019.

Mrs. Boxie thanked those in attendance for coming and announced the next meeting of the City of Baker School Board would be held on Tuesday, May 7, 2019, beginning at 6:00 p.m.
